and that we would like a representative to attend an upcoming Council  
meeting to discuss preferred offsets.

G.& L. the S ½ of 18-47-7w3 we approve of the installation of one 150 Watt high  
Developmt pressure sodium-vapor luminar at the highway entrance and one at the Y  
Damour intersection of A J Cantin Drive and E Cantin Lane at the expense of  
Lake Street G. & L. Developments with monthly operating cost of \$12.80 to be paid  
Lights by the municipality. The letter should also state that no construction or  
installation of lines should be done until the plan of subdivision has been  
registered with Information Services Corporation.

NCTPC Committee stating that the R.M. of Leask is willing to host either a phase I  
or phase II workshop for Power Mobile Equipment training.
