The Minutes of the Regular Meeting of the Council of the Village of Leask which was held in the Leask Municipal Office on Wednesday, August 19th, 2009 with Councillors Gordon Harris, Lorraine Madsen, Arthur Spriggs, Merv Prystupa, Mayor Robert Hryniuk, and Administrator Wanda Boon present.

The meeting was called to order at 7:22 P.M. by Mayor Robert Hryniuk.

- Res #198 /09 SPRIGGS: That the agenda for the August 19th, 2009 meeting of Council  
Agenda be adopted as presented. Carried.
- Res #199/09 HARRIS: That the minutes of the July 15th, 2009 Regular Meeting of

- Res # 200/09 MADSEN: That we write a letter to the Leask Housing Authority stating  
Senior's that Council was unaware that the yard lights at the Senior's complex are  
Lights being paid for by the Village and asking if they will consider paying  
\$30.00 per month for their outside lights.
